Old Business:

- II. FY19 Budget Final budget was distributed to the Board. \$65,000 for leasing a building was removed.
- III. Review of 2018 Primary Election
 - a. Pre-election Activities
 - i. Election Judge Training (curriculum) to be reviewed prior to September Training.
 - ii. Early Voting Jim Schultheis asked if there was any way to police the situation in the front parking lot, where candidates were flagging down cars on their way to vote. Kaye Robucci said, to the best of her knowledge, there is no way to do that if the candidate is outside the 100ft no electioneering zone, but she would check with board attorney, Roger Schlossberg.
 - iii. Packing of supplies Kaye Robucci said that part time workers Audrey Coffelt, Cindy Russell and Larry Shipe did a great job.
 - iv. Delivery of Voting Equipment went very well, even with road closures in south county, due to flooding.
 - v. Supply Pickup (enough helpers, Saturday and Monday) Kaye Robucci said there were more judges picking up on Monday than in the past, which is a problem, because we are not staffed to handle Monday pickups as well as Saturdays.

b. Election Day

- i. Polling Place Visits -
 - 1. Tammy Downin reported that election judges complained of unclean conditions at Precincts 09-000, Leitersburg and 14-001, Ringgold.
 - 2. Jim Schultheis noticed that some election judges are still hovering too closely to voters at Steps 3 and 4.
 - 3. Tammy Downin said chief judges at Maranatha Brethren Church asked for chalk to line their 100ft no electioneering zone.
 - 4. Marty Lumm received numerous complaints from voters about campaigners being too aggressive.
- ii. Election Workers
 - 1. Board members observed that, in general, chief judges are still not filling out hourly voter count totals properly.
 - 2. Kaye Robucci wants to go back to separate ballot stacks for regular and provisional voting, rather than "one bucket of ballots."
- iii. Equipment issues (paper jams, shorter ballots) Things went well overall, two or three issues with scanning units jamming.
- iv. Food Everyone enjoyed the food catered by Desert Rose Café in Williamsport.
- v. Election Night Activities (tasks, return process, enough helpers and flatbeds)
 - 1. Discussion of Maugansville Ruritan chief judges returning to the warehouse after 10:30PM on Election Night. Bruce Field suggested we stress to chief judges to alert the Board if they will be late or need help.
 - 2. Bill Blazes thought we needed another cart with a box to load bags.

- 3. Barry Jackson reported that the newly instituted number system for returning chief judges worked well. He requested an additional flatbed cart and six total helpers for unloading chief judge vehicles on General Election night.
- c. Post Election Activities
 - i. Canvasses (AB1, Provisional, AB2) Jim Schultheis requested that we add an agenda item for a future meeting to talk about the Provisional process. He believes the provisional ballot application is confusing regarding party affiliation and would like to see it changed. Peter Perini said he felt the absentee and provisional canvasses went smoothly. Jerry DeWolf also mentioned that members of his committee attended the canvasses and reported back that they went very well.
 - ii. Use of BMD for duplicating went well.
 - iii. Audit Procedures went well.
- IV. MAEO Personnel Actions Status Update Marty Lumm asked what can be done to get Election Board staff members a raise. Kaye Robucci said that the MAEO Personnel Committee has created new positions that would allow for pay increases, but it must be approved by the State Board of Elections.

New Business:

- I. Absentee delivery issues Kaye Robucci reported that there was a number of voters who requested absentee ballots and did not receive their ballots. We need to find out how prevalent this problem was around the state, and what can be done to keep this from happening in the General Election.
- II. Petition Candidates Kaye Robucci reported that we are currently processing petitions for John Barr, William "Bill" McKinley, and George "Matt" Feiser.
- III. PEPs Performance Evaluation Process (Closed Session) PEPs are due on July 13th.
- IV. EW Training location Kaye Robucci will call Mark Mills with the Board of Education to confirm dates for General Election training.
