F. Electronic Pollbook Update

E-mail from Ross Goldstein, SBE, regarding electronic poll books. There is a possibility that printers may be available for the primary election, otherwise, SBE will print VAC's to use. Washington County will receive 141 electronic poll books. Washington County will also be the location for one of the duplicators.

G. Board of Education

Letter to Tony Mayhew, Board of Education, requesting the use of 29 schools on Election Day. The Elementary Schools are in process of changing from analog to digital prior to the primary election. Mr. Foltz will give Charles Mobley a list of those phones that will change. We may need to purchase new phones.

B. Registration Figures

Total registration is 84,000. Deadline to register to vote is August 22, 2006.

Charles Mobley suggested that the Board go ahead and vote during Early Voting.

Old Business:

A. Court Case, Charlie Baker aka Roger Webber.

The Court case is re-scheduled for October 26, 2006. Clair Baker informed the Board that he left a message for Art Rozes to call him. Clair Baker explained that Charlie Baker aka Roger Webber filed a request to change his name (at the same time that his name was removed from our voter rolls) but he didn't pay the filing fee. The Board's decision of 2005 still stands.

B. Confidentiality of Voter Records

The Board reviewed the new procedures for Voter Confidentiality. Eileen Wiggins made a motion to approve the new procedures; Clyde Tate seconded the motion and all were in favor.

New Business:

A. Newspaper Ads

The Board reviewed the newspaper ads for the primary election.

B. Mailer for Early Voting

Every registered voter must receive information regarding Early Voting. The specimen mailer will cost approximately \$15,000 with postage.

Early Voting will be held September 5 – 9, 2006. Electronic Poll Books – 3 Chief Judges – 2 Check-in Judges – 6 Unit Judges – 3

C. Parallel Testing

Parallel Testing will be conducted at the same time as the public demonstration on September 1, 2006 starting at 10:00. Two units are randomly selected, one to be used during the public demonstration and the other to be tested by SBE on Election Day.
