A. Change of polling locations

The Board discussed the need to change the polling location for Districts 15 and 26-1. We would like to make the change before June 30, 2007. They discussed the use of Park Head United Methodist Church for District 15 and St. Joseph's Catholic Church for District 26-1. Dorothy Kaetzel will call Park Head United Methodist Church and Charles Mobley will call St. Josephs.

Charles Mobley will also review the projected growth for Washington County.

B. City of Hagerstown Elections

Kaye Robucci informed the Board that William Nairn, Attorney, for the City of Hagerstown, was inquiring about the 2006 Legislative Changes that may impact the City. Dorothy Kaetzel informed the Board that in the future only local candidates will file at our office and SBE would be responsible for all campaign fund reports. We will have access to the paperwork but will not be reviewing the campaign fund reports. Dorothy Kaetzel also informed the Board that the City of Hagerstown will be updating their Charter. Charles Mobley and Dorothy Kaetzel will discuss this further to plan how to proceed.

C. Budget FY08

The Board reviewed the budget and made the following changes:

- 500005 Wages Part Time
 - Charles Mobley made a motion to increase the part-time wage to \$15.00/hour; Eileen Wiggins seconded the motion. Motion unanimously approved.
 - Charles Mobley made a motion to increase the Substitute Board Members wage to \$15.00/hour; Eileen Wiggins seconded the motion. Motion unanimously approved.

- 535000 Rentals

 - The Board discussed the need for additional help in moving the voting equipment. The amount of \$400.00 will be added to cover this cost.
