#### **New Business:**

- FY21 Revised Budget The county made some adjustments to the budget, in an effort to reduce costs. Kaye Robucci will send the Board the Revised FY21 Budget.
- II. Polling Place Evaluation Program Only the Vote Center on Election Day will be evaluated. Jim Schultheis volunteered to complete the evaluation.
- III. Live Streaming SBE is assisting us with live streaming the canvass. There will be three cameras that the public can view during the canvass.
- IV. Pay for Election Judges the Board discussed additional pay for the Election Workers (due to COVID-19) for assisting with the canvass and working on June
   2. Jim Schultheis made a motion to pay \$15/hour for canvass and extra \$100/day for Election Day workers; Bill Blazes second and it was unanimously carried. Jim

Schultheis also recommended box food (breakfast, lunch, dinner) for election judges at Vote Center on Election Day. The Board agreed.

V. Municipal Elections – Kaye Robucci reported that Boonsboro and Smithsburg moved their elections to June 9<sup>th</sup>, Keedysville is July 19<sup>th</sup>, and Funkstown is in August. Smithsburg is doing a drive-by election.

#### Members Remarks:

Marty Lumm allowed this time for public comments.

Peter Perini had the following comment and/or questions:

 Question: Do the ballot packet instructions incorrectly state for the voter to include postage on their returned ballot?
 Answer: The voter should not have to include postage for the Presidential Primary Mail in Ballot. Kaye Robucci will review the ballot packet instructions again and let Peter know. The ballot packet instructions for the Congressional 7 Special Election were incorrect regarding postage.

Seth Wilson had the following comments and/or questions:

- Question: Will the live stream be recorded?
   Answer: Yes, the live stream will be recorded.
- 2. Question: Have we received occupancy permit for the Vote Center?
  Answer: Yes, we have a 3 month temporary occupancy permit for Virginia Avenue.
- 3. Question: Please provide clarification on entering a ballot in MDVOTERS.

  Answer: Kaye Robucci explained that it means the ballot has been received into the system. It is not counted until the canvass.
- 4. Question: Can a report be generated that lists who has returned their ballot and who has not returned their ballot?
  - Answer: Kaye Robucci said she will look into it and let him know.
- 5. Question: Are campaign signs allowed to be put out at the Vote Center during the Early Voting period (May 21-28).
