# B. Statutory changes for AB – High risk professions

Donna Duncan sent an Opinion of the Attorney General from September 1998. The opinion recommends that if a voter requests an absentee ballot; it is not the responsibility of the staff to determine if the voter has made the decision properly. If the voter signs the oath, a ballot should be issued.

## C. Chewsville Community Center

The Board discussed the use of the Chewsville Community Center. We have received permission to use the facility but the permission slip included a list of stipulations. The Board recommended not sending any "I Voted Stickers" to the Community Center. The Board decided to continue to use the Community Center for now. Charles Mobley will check if the evening meeting scheduled at the Community Center could be rescheduled.

## D. Redistricting Resolutions

The redistricting resolutions are on hold until a decision is made by the Court of Appeals.

# E. Redistricting Notifications

Dorothy Kaetzel contacted The Printing Place to put the printing and mailing of the Voter Notification Cards on hold until further notice.

#### F. Election Worker Notifications

Election worker recruitment letters were sent to 1,000 registrants. We have received a good response so far.

#### G. Old Phone Number

#### H. FY03 Budget

Dorothy Kaetzel received her FY03 Budget. Nothing additional was deleted.
