- G. Candidate Information:
 - 1. Filing began February 23, 2021. 11 Candidates have filed.
- H. Voting System Activities:
 - 1. Preparing work area for charging of Scanning Units.
- I. Projects continue to move in to new place.
- II. Attorney: New stadium is billed as a multi-use sports and events center. Brian Kane suggested we should contribute to the design to ensure indoor facility is sufficient for an Early Voting Center/Polling Place. Board asked Kaye Robucci to contact Senator Paul Corderman to discuss using the new stadium (SB926).

Old Business:

- I. Virginia Avenue Update
 - A. Warehouse move took one day, rather than the estimated three days.
 - B. TVs are in, need to be installed.
 - C. Still working on replacing HVAC system.
- II. FY22 Budget: budget was approved. There are currently insufficient funds for the purchase/rental of the replacement pollbooks. Kaye Robucci has contacted County Budget and Finance regarding the potential cost of \$402,000 for replacement pollbooks.
- III. 2nd (and 3rd!) Early Voting Site Kaye Robucci put a guideline document together for the Board to show what we are looking for in an Early Voting site. The Board discussed locations for possible sites:
 - A. Downtown (Washington County Free Library, Applause Catering)
 - B. South County (Fairplay Fire Hall, Funkstown Fire Hall, Keedysville Community Center)
 - C. Third Area (Leitersburg Community Center)

The Board will discuss pros and cons of several locations at the July Board Meeting. Jim Schultheis will contact the fire halls and the Keedysville Community Center and Kaye Robucci will contact the Washington County Free Library. Barry Jackson will contact Bonn Poland regarding additional map layers.

- IV. Pollbook Replacement Project Update:
 - A. Committee is performing an on-site evaluation of 4 vendors;
 - B. SBE hopes to have a proposed solution by early July;
 - C. Plan to present solution to Board of Public Works by September;
 - D. Contingency plan to use existing pollbooks.

 - B. An area at 101 Tandy Drive
 - C. Western Maryland Center
 - D. Department of Social Services

Kaye Robucci will research what is the required time frame for the back-up work location to be up and functioning.
