President Tammy Downin called the meeting to order at 3:02 pm at the Washington County Election Center, 17718 Virginia Avenue, Hagerstown, MD 21740. There was a quorum present.

Donna Brightman moved to accept the minutes, for July 11, 2023 as amended, Nancy Armstrong seconded, and the motion was carried unanimously.

 - Teresa Morningstar hired as Deputy Director, beginning July 26, 2023.

Donna Brightman asked the status of the RICO lawsuit?
Barry Jackson stated there has been no update regarding the lawsuit and the Local Boards still have to hold the 2020 election materials.

<u>Unfinished Business:</u>

I. Early Voting

Barry Jackson presented a spreadsheet of the 5 potential early voting sites along with all of the requirements and factors that the board should consider when deciding the early voting site.

For the requirement regarding the electioneering zone the Washington County Free Library was answered Yes and No, because at the front of the library, the electioneering zone extends onto the sidewalk on the other side of the street, and there is no way to enforce the no electioneering zone. Tammy Downin asked if we could put a sign in the front of the library directing voters to use the rear entrance? Barry Jackson stated that this was done at the library during the November General Election when the Mummers parade occurred.

Donna Brightman asked the staff's opinion on weighing the factors to be considered. Barry Jackson stated that, in his opinion, how many voters are being reached by the sites would be the most important factor, then the next most important would be the accessibility of the early voting sites to historically disenfranchised communities.

A public hearing will take place to allow public comments regarding the possible early voting sites.

Martin Lumm stated that the Election Center is perfect for an early voting site as people will come there to vote. Martin Lumm asked if the county commissioners were asked if they will fund a third site if Washington County is shy of the 100,000 voter threshold, especially if it is short by 100 or 200 voters? Barry Jackson replied that the county commissioners were not asked this.

Derek Harvey stated that he can't speak for the other county commissioners, but he

believed that they should just "bite the bullet" and grant a third site. Derek Harvey stated that he was disappointed that the Washington County Free Library didn't do better and that he did not know the exact number for how many voters used the center. Tammy Downin stated that in comparison with other counties for a first-time early voting site the Washington County Free Library did better than other counties for voter turnout.

Tammy Downin asked if September 26, 2023 is enough time to allow for the Public Hearing?

Barry Jackson stated that September 26, 2023 would allow enough time for notice to be posted.

The Public Hearing will take place on September 26, 2023 at 7:00 pm.

The Board will make a decision on the early voting sites at the October 10, 2023 board meeting.

II. Polling Place Plan

Barry Jackson presented the polling place plan spreadsheet that he and Teresa Morningstar have been working on, as well as some of the questions that they have to answer for the state.

Angela Batista asked, other than moving out of the county, how else do people become inactivated and do they receive notification that they are inactivated?

Teresa Morningstar replied that felon reports are worked, and anytime the Board of Elections is notified that someone has passed away, they become inactivated. Voters are notified prior to becoming inactivated.

Martin Lumm stated he would like to see the voting centers spread out, rather than being two miles apart.
